Adhesion Contract



This contract shall be in force with the date signed and for all visits thereafter to Snowflake Pet Center.

I, _____ hereby certify that my dog(s) _____ is/are in good health and have not been ill with any communicable diseases in the last 30 days, and my dog(s) has/have current vaccinations for Rabies, DHPP, and Bordetella. Dogs 6 months of age and over must be spayed or neutered. Dogs arriving with fleas and/or ticks may be treated with flea/tick preventative at Snowflake Pet Center's discretion, at my expense. I further certify that my dog(s) has/have not harmed or shown aggressive or intimidating behavior towards any person or any other dog. I give authorization to Snowflake Pet Center to speak with my veterinarian and/or their staff to confirm my dog(s) vaccination status, date of surgical alteration and medical history.

I have read and understand the following:

- 1) Snowflake Pet Center is an open play environment and because dogs' pack instincts can at times be unpredictable, there are inherent risks, which even when closely monitored, may result in the following: 1) transfer of communicable illness such as, but not limited to, Bordetella virus "kennel cough" and 2) Injuries such as, but not limited to, broken nails, sore pads, abrasions, lacerations, punctures and/or cuts etc. Snowflake Pet Center is not liable for any such illness or injury.
- 2) Snowflake Pet Center and their staff shall not be liable for any injury or damage to any persons, animals or to any property, however caused, which results from the training, behavior, care or grooming of my pet to any negligence on the part of any other pet owner attending Snowflake Pet Center. I further agree that Snowflake Pet Center shall not be liable for any costs, attorney's fees or expenses incurred in connection with any claim, action or proceeding occurring as a result of my pet's participation at Snowflake Pet Center.
- 3) Snowflake Pet Center reserves the right to administer aid and/or use any available veterinarian for my pet if the need arise, whether or not Snowflake Pet Center can reach me or my emergency contact; the contact information provided on the application. Snowflake Pet Center will make reasonable efforts, based on the circumstances presented; to contact the owner before any such care is administered. I assume full financial responsibility for any and all veterinary expenses incurred, in addition to other fees incurred for services provided at or by Snowflake Pet Center.
- 4) I agree to pay the rate for services in effect on the date my dog(s) attend(s) Snowflake Pet Center. Prices are subject to change at any time. No dog will be released until all charges are paid in full. I understand all fees are non-refundable.
- 5) I am solely responsible for costs for repairs to property caused by my dog(s) and will be my sole responsibility while my dog(s) is/are attending Snowflake Pet Center.
- 6) Snowflake Pet Center reserves the right to refuse services or admittance to any dog.
- 7) I agree that I have given full disclosure of any history of aggressive behavior by my dog, and understand that failure to do so will result in my dismissal from Snowflake Pet Center and no refund shall be given. My dog's behavior now and in the future is solely my responsibility. Should any behavior on the dog's part now or in the future result in damage to the property, owners, or person, I agree to assume full liability for any and all such damage, and to absolve Snowflake Pet Center from any and all obligation to pay for such damage.
- 8) I understand that the hours of operation are from 6:30AM to 6:30PM Monday through Friday, Saturday 8AM through 4PM. Dogs not picked up by closing will be subject to an additional boarding charge and will be released the next day unless arrangements with Snowflake Pet Center are made to the contrary.
- 9) Should I or my pre-approved agent fail to contact Snowflake Pet Center within 48 hours of the arranged pick up time, my pet may be considered to be abandoned in accordance with Connecticut General Statutes. Any expenses incurred for the transport, overnight care, and/or placement or adoption of said pet shall be paid by me, in addition to other fees incurred for services as a result of such abandonment. I hereby grant a lien on said pet for any and all unpaid charges resulting from services provided, by, at, or through Snowflake Pet Center.
- 10) I the owner/representative, have had the opportunity to inspect the premises and are satisfied with its condition.
- 11) I agree my pet(s) may be videotaped, photographed and/or recorded. Snowflake Pet Center shall retain the exclusive right to the results and all proceeds of such tapings, photographs, and recordings with the rights throughout the world, and unlimited number of times in perpetuity, to copyright, to use and to license to others in any manner.
